Government Resolution

Exposure to these global practices and technologies will enable the adoption of export-compliant production systems, support evidence-based policy and investment decisions, and enhance the quality, productivity, and global competitiveness of agricultural commodities from Maharashtra.

The proposed study tour under the leadership of the Hon'ble Minister (Marketing & Protocol), Government of Maharashtra, will facilitate strategic interactions with global manufacturers, experts, and policymakers, enabling international collaboration, pilot projects, and future investments. The visit will also support discussions with relevant stakeholders regarding opening the U.S. market for Indian agro produce, thereby strengthening agricultural exports. Overall, the tour will play a crucial role in strengthening the agricultural value chain, empowering Farmer Producer Organizations, and promoting adoption of international-standard technologies, contributing to the long-term growth of agriculture and agri-exports from Maharashtra.

Considering above potential benefits, the Government of Maharashtra, through Maharashtra State Agricultural Marketing Board, Pune, has planned a study visit for Shri. Jaykumar Jitendrasinh Rawal, Minister (Marketing & Protocol), Government of Maharashtra along with the officials to USA from 9th to 16th February, 2026, inclusive of travel time.
